

PERSONAL DATA PROCESSING INFORMATION

This informative notes indicates the procedures the committee uses in order to process your personal data according to the current legislation (law 171/2018) and the consequent rights and commitments.

We would like to inform you:

1. Data holder

The data holder is “Comitato RSM Tango”, Address: Via 4 Giugno 17 Serravalle, 47899 Repubblica di San Marino and e-mail "rmstango@gmail.com".

2. Purpose of the processing data

Your personal data will be processed in order to accomplish the complete organization of the event, “Tango in...Christmas Time” 18-19-10 December 2020.

3. Legal basis of your personal data

The processing of your personal data is based with an official agreement, according to the law 171/2018, expressed by the person in order to fulfill the necessary procedures of the event. The consent is not mandatory and can be removed at any time sending an email to the data holder. In that case, the processing of your personal data is necessary in order to fulfill a legal obligation of the data holder.

4. Data source

Personal data are collected directly from the person who register at the event and they are processed according with the obligations of transparency and correctness protecting the privacy of the person

5. Provision of data and refusal

The provision of data requested is mandatory according to the current law regulation. Failure to provide data could stop the data being processed.

6. How personal data are processed

Personal data are processed through manual, IT and telematic tools in relation with the purpose of the event “Tango in...Christmas time” 19-19-20 December 2020, in order to guarantee safety and privacy. The owner must guarantee and check personal data using the appropriate and specific measure to avoid data distruction, losing or not-authorized access. Personal data will be kept for the entire time of the event and further on for the necessary accomplishment of the purpose

7. Categories of the processed data

Data providing racial and ethnic origin, with reference to the citizen certificate, health and sexual life or sexual orientation, political, religious and philosophical faith and everything related to “Specific Personal Data” and also penal sentences or crime, will be processed after the approval of the owner according to the fulfillment of the event .

8. Categories of data recipient

Data processed by the “Comitato RSM Tango” could be distributed to private or public agencies in compliance with the current law

9. Transfer of data abroad

Personal data won't be transferred abroad, EU countries included, or to international organizations

10. Rights of the customers

The rights of the customers are regulated by the Law 171/2018, art 15 to 25They are:

- Ask for the confirmation of their personal data

- Log in at any time to the data- Get information about the purpose of the processing data, the categories, the recipient to which personal data will be communicated and the duration of the storage

- Ask for the correction and, in case of violation of them, or if they are incomplete, to cancel all the data
- Ask for the restrictions of the processing
- Obtain data portability and receive them from a data holder, in a structured format, readable by an automatic device, and transfer them to another holder without restrictions
- Ask for the refusal of personal data processing at any time and for any reason
- Disagree with the decision-making process related to people including profile
- Ask the data holder for the update , integration or limitation of their data
- Remove the confirmation of their personal data at any time without compromising the transparency of the agreement
- Make a complaint to a supervisory authority in the country where he usually lives or works, or in the place where the violation has happened

The mentioned data can be claimed at any time writing to the owner.
